Principal activity

The Trustee acts as trustee for LGIAsuper. LGIAsuper is hereafter referred to as (the "Fund"). The Trustee acts solely as trustee of LGIAsuper. The Trustee has no beneficially owned assets – all Fund assets are held for the benefit of members.

Operating result

The Trustee did not trade in its own right during the current or previous financial year.

Review of operations

Throughout the year, the Trustee has continued to act as trustee for the Fund. The Fund is a public offer superannuation fund.

Audit and non-audit services

Details of the amounts paid or payable to the auditor (PricewaterhouseCoopers Australia) for audit and non-audit services during the year are disclosed in note 7.

The Trustee may decide to employ the auditor on assignments additional to their statutory audit duties where the auditor's expertise and experience with the company is important.

The Board of directors, in accordance with the advice provided by the audit committee, is satisfied that the provision of non-audit services is compatible with the general standard of independence for auditors imposed by the *Corporations Act 2001*. The directors are satisfied that the provision of non-audit services by the auditors did not compromise the auditor independence requirements of the *Corporations Act 2001* for the following reasons:

- All non-audit services have been reviewed by the audit committee to ensure they do not impact the impartiality and objectivity of the auditor, and
- None of the services undermine the general principles relating to auditor independence as set out in *APES 110 Code of Ethics for Professional Accountants*.

Proceedings on behalf of the company

No proceedings have been brought or intervened in on behalf of the Trustee with leave of the Court under section 237 of the *Corporations Act 2001*.

Mergers

On 31 May 2023, LGIAsuper merged with SPSL Master Trust. The merger was by way of a Successor Fund Transfer (SFT) which involved SPSL Master Trust member's and their benefits being transferred to LGIAsuper. The merger created a single fund, which is managed by the LGIAsuper Trustee.

Administration Migration

From 16 September 2022, the administration of former Energy Super members were migrated into LGIAsuper, resulting in a change in the administrator of members' funds from Link Market Services to Tech Mahindra.

From 1 June 2023 SPSL Master Trust's members were migrated into LGIAsuper, resulting in a change in the administrator of members' funds from SPSL Limited to Tech Mahindra.

Significant events after the balance date

On 23 August 2023, SPSL Limited approved the transfer of its role as trustee of SPSL Pooled Superannuation Trust to the Trustee. The Trustee agreed to act as the trustee for SPSL Pooled Superannuation Trust on 25 September 2023, effective 1 October 2023.

There have been no other matters or circumstances not otherwise dealt with in the financial report that have significantly affected or may significantly affect the Trustee since the end of the financial year.

Environmental regulation and performance

The Trustee is not subject to any particular or significant environmental regulation.

Indemnification and insurance of Directors and auditors

During or since the financial year, the Trustee has paid premiums from the Fund in respect of a contract insuring all of the Directors of the Trustee against costs incurred in defending any legal proceedings against them. The total amount of insurance premiums paid was \$301,906 (2022: \$331,081).

The company has not, during or since the end of the financial year, indemnified or agreed to indemnify the auditor of the company or any related entity against a liability incurred by the auditor.

During the financial year, the company has not paid a premium in respect of a contract to insure the auditors of the company or any related entity.

Note 1. Corporate information

The Trustee is a statutory corporation formed under the *Local Government Act (Queensland) 2009* that is incorporated and domiciled in Australia. The registered address of the Trustee is Level 20, 333 Ann Street, Brisbane, Queensland, 4000.

The Trustee acts solely as trustee of LGIAsuper. The Trustee has no beneficially owned assets – all Fund assets are held for the benefit of members.

Note 2. Statement of Significant accounting policies

(a) Basis of accounting

This financial report is a general purpose financial report, which has been prepared in accordance with Australian Accounting Standards (including Australian Interpretations) adopted by the *Australian Accounting Standards Board (AASB)* and in accordance with the requirements of the *Corporations Act 2001*. The accounting policies used in the preparation of this report, as described below, are consistent with previous years, and are, in the opinion of the Directors, appropriate to meet the needs of ASIC and the Directors. The financial report has been prepared on an accrual basis of accounting including the historical cost convention and the going concern assumption. The functional presentation currency for these statements is Australian dollars.

(b) Statement of compliance

Compliance with IFRS

The Financial Statements are prepared on the basis of the revised Australian Accounting Standards, which include Australian equivalents of International Financial Reporting Standards ("AIFRS").

(c) Application of Accounting Standards

New and amended accounting standards and interpretations

There are no standards, interpretations or amendments to existing standards that are effective for the first time for the financial year beginning 1 July 2022 that have a material impact on the amounts recognised in the prior or current periods or that will affect future periods.

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 July 2023 and have not been adopted early in preparing these financial statements. None of these are expected to have a material impact on the financial statements of the Trustee.

(d) Change in accounting policies

The accounting policies adopted are consistent with those of the previous year.

(e) Trustee obligations

The Trustee in its capacity as trustee incurs liabilities on behalf of the Fund. During the year, all liabilities incurred by the Trustee have been in accordance with the Trust Deed. In respect of the trustee liabilities, the Trustee has a right to be indemnified out of the assets of the Fund.

These financial statements have been prepared for the Trustee and as such do not record the assets and liabilities of the Fund. At balance date, the assets of the Fund are sufficient to meet its liabilities. The assets of the Fund are not available to meet any liabilities of the Trustee acting in its own right.

Note 3. Profit from ordinary activities

All expenditure incurred in administering the Fund is reimbursed from the Fund's net assets. Accordingly, there was no result for the financial year nor was there any information concerning profit and loss account items required to be disclosed.

Note 4. Directors' remuneration

No remuneration has been received, nor is due and receivable, by the Directors of the Trustee. Instead, remuneration is paid from the Fund and declared in the Fund's audited financial statements.

No amounts have been paid to superannuation funds from the Trustee, in connection with the retirement of the Directors of the Trustee. Instead, superannuation, as with remuneration, is paid from the Fund's net assets.

The Trustee's auditor is PricewaterhouseCoopers. Audit fees are paid directly by the Trustee from the Fund. Audit Fees of \$10,260 (2022: \$9,500) were paid or payable on behalf of the Trustee for the financial year. No non-audit fees were paid or payable on behalf of the Trustee.

Note 8. Indemnification

The Trustee acts solely as trustee of LGIAsuper. These financial statements have been prepared for the Trustee, and as such do not record the assets and liabilities of the Fund as the Trustee will only be liable for the obligations of the Fund if it has committed a breach of its fiduciary duties, or to the extent that the Fund has insufficient assets to settle its obligations. The Trustee has a right of indemnity from the Fund in respect of its liabilities, which have not been recognised in its financial statements for the period ended 30 June 2023.


